Fund Manager's Comment

The Fund's net performance for the month of November 2024 came in at positive 0.22%, outperforming the benchmark by 21bps. IDR denominated Government bonds prices generally fell in November 2024. This is indicated by the yield of FR100 (10 Year benchmark) increased from 6.77% to 6.85%. In addition, the yield of 5 Year benchmark, FR101 increased from 6.65% to 6.73%.

The Rupiah depreciated against USD from previous level of 15,698 to 15,848. Inflation in November stood at 0.30% MoM, compared to previous month at 0.08% while annual inflation stood at 1.55% YoY with the previous month at 1.71%. Foreign ownership in Government bonds has fallen from IDR 886Tn to IDR 873Tn. Foreign investors currently have 14.59% of total Government bonds, while previous month level at 14.89%. Currently, IDR bond portfolio duration is 7.06 yr. Going forward, we remain positive on the local bonds market. We expect the fund to benefit from the current rate cut cycle.


