Fund Manager's Comment

The Fund's net performance for the month of December 2024 came in at +0.14%, underperfoming the benchmark by 15bps. The average 1-month time deposits rate banks in Indonesia increased in December 2024. The rates increased by 8bps to 4.14% from 4.06% at the end of the previous month. The average 3-month time deposits rate banks in Indonesia increased, as indicated by the increased rate from 4.33% to 4.35%. Meanwhile, 1-year Govt Bond yield increased by 30.5bps to 7.009% from 6.704% at the end of the previous month. The BI Rate at the end of December 2024 was steady at 6%. Going forward, we remain positive on the local bonds market. We expect the fund to benefit under the current rate cut cycle as some of the allocations are invested in both government and corporate bond.




