## Fund Manager's Comment

The Fund's net performance for the month of January 2025 came in positive at 0.73%, slightly underperforming the benchmark by 1bps. USD-denominated government bonds price rose in January 2025, reflected by the yield of INDON 2035 that decreased from 5.41% to 5.39%. The Rupiah depreciated against USD from previous level of 16,132 to 16,305 USD. While the US 10 Year Treasury generic yield decreased from 4.57% to 4.54% in January 2025. Currently, USD Bond portfolio duration 4.55 yr. Going forward, we remain positive on bond market especially on Indonesian USD Government Bonds. We expect this fixed income fund to benefit under the current rate cut cycle.

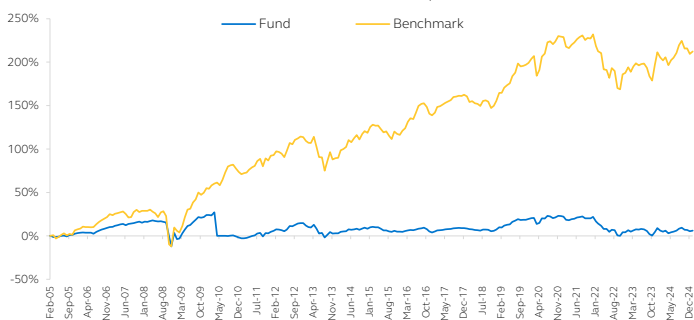

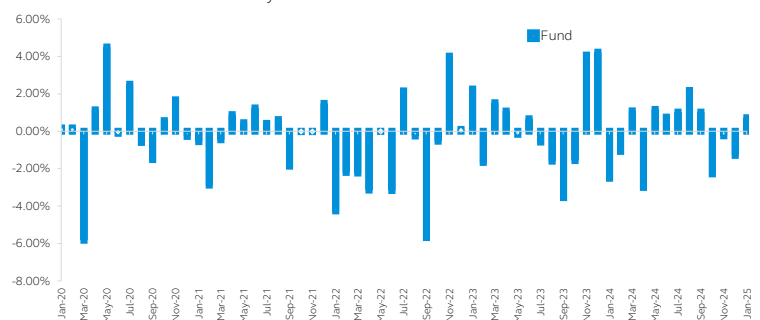
