Fund Manager's Comment

USD-denominated government bonds price generally rose in August 2024, reflected by the yield of INDON 2034 that decreased from 4.96% to 4.70%. The Rupiah appreciated against USD from previous level of 16,260 to 15,455 USD. While the US 10 Year Treasury generic yield fell from 4.03% to 3.90% in August 2024. Currently, USD Bond portfolio duration 5.65 yr.

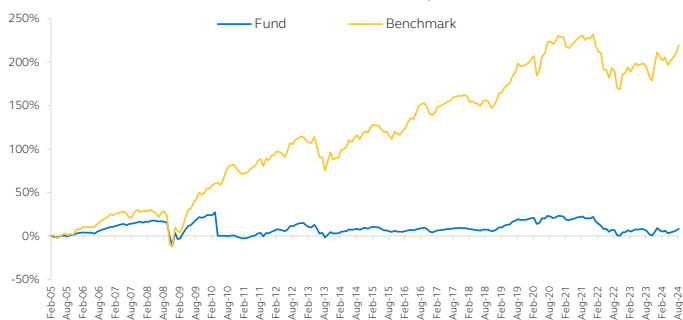

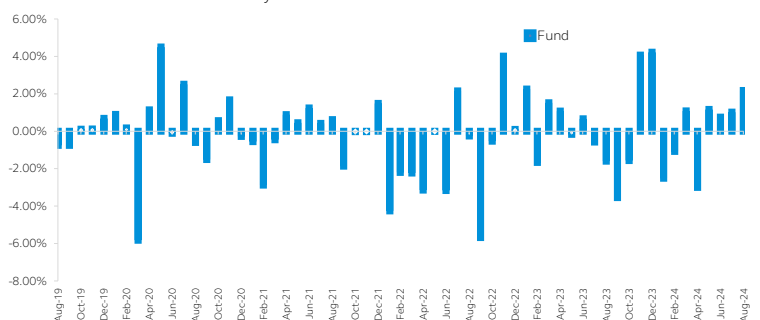
