## Fund Manager's Comment

In January 2025, the MSCI ASEAN Index (MISO) fell by 1.39%. Malaysia, Indonesia and Philippines posted negative return due to the looming concern over trade war caused currencies in the region to plunge and all sectors except for Telecommunications were also negative. On the other hand, Singapore became the only country in the region that able to register positive return led by Singapore Telecommunications (Singtel). Singtel raised its interim dividend by 35% to seven cents as it reported higher underlying first-half earnings.

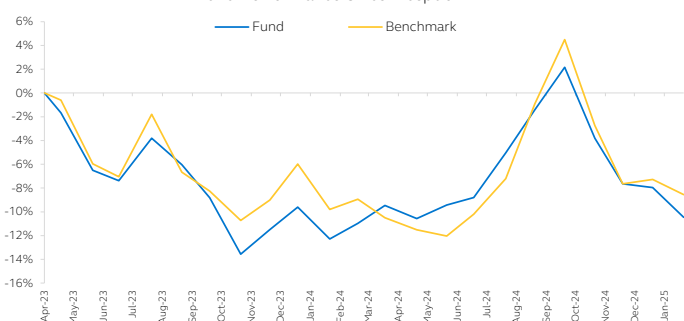

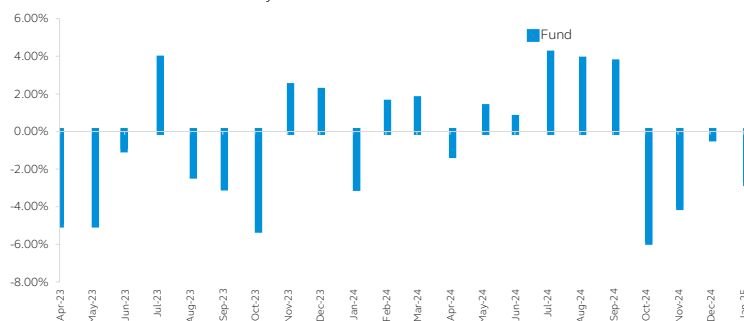
