## Fund Manager's Comment

In January 2025, the MSCI Asia Pacific Islamic ex Japan Index (MIAPJ) increased by 0.80%. South Korea and Australia became the best performers among the regions. Information Technology and Materials were among the best performing sectors driven by investors' enthusiasm over AI led by SK Hynix and the reemergence rumour of merger between BHP Group and Anglo American. On the other hand, India became the worst performer due to the depreciation of its Rupee as it fell by 1.16% during the month.

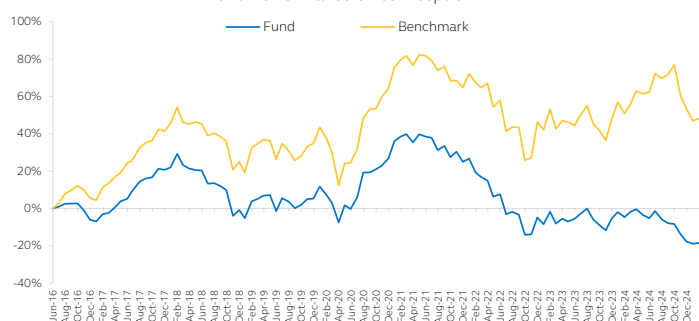

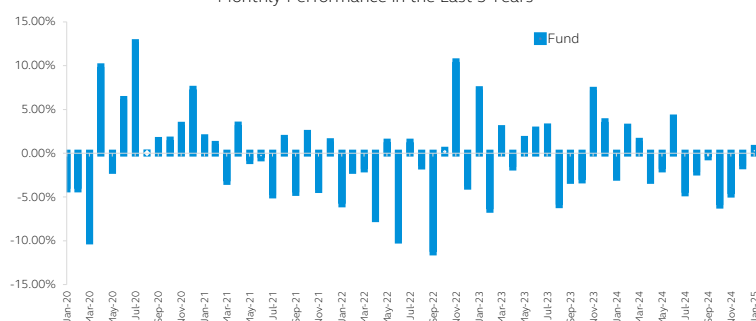
