#### Fund Manager's Comment

In June 2024, the MSCI Asia Pacific Islamic ex Japan Index (MIAPJ) closed higher by 3.4%. Taiwan, India, and South Korea were among the best performers while Hong Kong and Australia were the biggest laggard. On sectoral basis, Information Technology and Energy were the best performers while Materials and Real Estate became the main laggard. TSMC and was the top gainers due the strong sentiment for semiconductor while BHP Group Ltd was the main laggard due to the uncertainty of its acquisition on Anglo American.


