## Fund Manager's Comment

In November 2024, the MSCI Asia Pacific Islamic ex Japan Index (MIAPJ) fell by 4.5%. South Korea and India became the worst performers due to the less dovish benchmark rate path after the Fed Chairman commented that "the Fed does not to be in a hurry to reduce benchmark rate" and potential of another trade war under the newly elected U.S President, Donald Trump. Donald Trump has announced that he will impose 25% tariffs on import from Canada-Mexico and 10% additional tariff to China. In terms of sector, Information Technology became the main laggard dragged by Samsung Electronics.

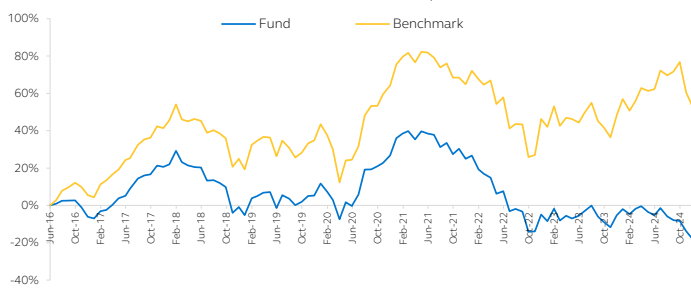

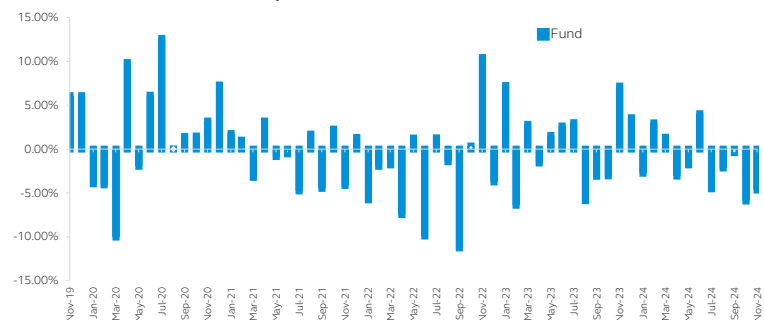
