Maintain the investment value and obtain a level of return in accordance with the level of risk acceptable in medium term through investments in fixed -income Debt securities and can invest in equity Securities and/or Money Market Instruments.

Fund Manager's Comment

The Fund's net performance for the month of December 2024 came in at -0.29%, underperforming the benchmark by 8bps. IDR denominated Government bonds prices generally fell in December 2024. This is indicated by the yield of FR100 (10 Year benchmark) increased from 6.85% to 6.97%. In addition, the yield of 5 Year benchmark, FR101 increased from 6.73% to 6.99%.

The Rupiah depreciated against USD from previous level of 15,848 to 16,132 per USD. Inflation in December stood at 0.44% MoM, compared to previous month at 0.30% while annual inflation stood at 1.57% YoY with the previous month at 1.55%. Foreign ownership in Government bonds has risen from IDR 872Tn to 880Tn, thus foreign investors currently have approximately 14.56% of total Government bonds, while previous month level at 14.53%. Currently, IDR bond portfolio duration is 7.14 yr. Going forward, we remain positive on the local bonds market. We expect this fixed income fund to benefit under the current rate cut cycle.

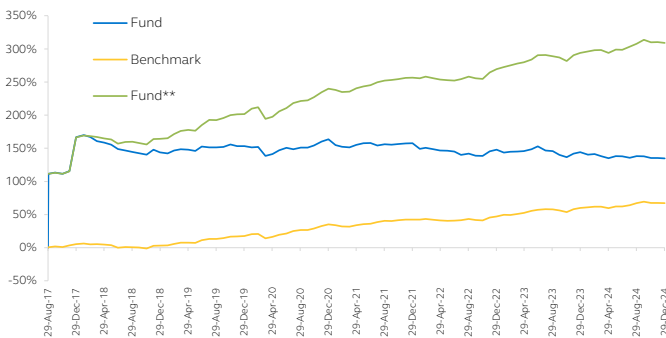

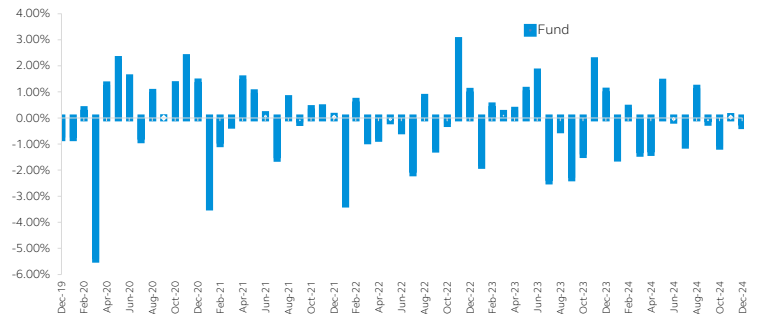
