Fund Manager's Comment

Sharia bond prices generally fell in August 2024. This is indicated by the yield of 10 Years benchmark PBS029 that increased from 6.68% to 6.70%. The yield of 5 Year benchmark price, PBS023 decreased from 6.63% to 6.55%. Currently, Sharia bond portfolio duration is 5,95 yr.

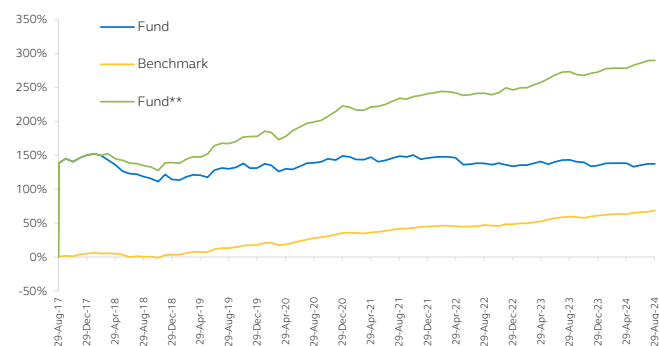

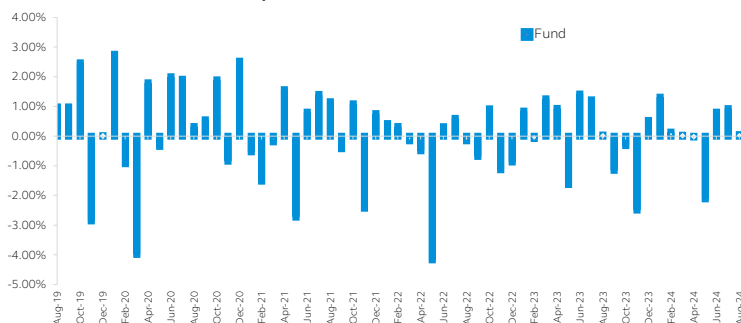
